- Never use aerosol, petroleum-based or other flammable products on or near shredder. Do not use canned air on shredder.

- 9 sheets per pass to avoid jams.

OPERATION


Disconnect power switch must be in ON (I) position to operate shredder. Insert waste bag (Fellowes #36052) for easy disposal.



Continuous operation: 3-5 minute maximum


NOTE: Shredder runs hriefly after each pass to clear entry Continuous operation beyond 3-5 minutes will trigger 15-minute cool down period.





TROUBLESHOOTING

Paper jam: Set to Off (O), remove shredder head and empty bin. Replace shredder head, and follow any or all of the below procedures.




Indicator lights:

- Yellow SafeSense® active
- ★ Yellow flashing SafeSense® not active Make sure head is on basket correctly Wait 15 minutes for motor to cool down

Remove and empty basket

ATTENTION: If the SafeSense® light remains on, you must engage the So Override Switch in order to perform steps above. Once the jam is cleared, reset the SafeSense® feature (See SafeSense® instructions below)

-X- SafeSense® paper iam: If the SafeSense® feature activates (SafeSense® light remains on) to cause the user to think the shredder has jammed when it has not, use the Q Override Switch to deactivate the SafeSense® feature and clear the paper. Warning — when switch is in override position, the SafeSense® light will flash and the SafeSense® feature will NOT function. Once the paper is cleared, reset the SafeSense® feature.






MAINTENANCE
